INVITATION TO BID

For the

CONSTRUCTION OF A FOUR (4) STOREY W/ DECK ACADEMIC BUILDING (Phase 1)

1. The Davao del Norte State College, through the **General Appropriations Act (GAA) 2019** intends to apply the sum of **Forty Five Million Pesos Only (Php 45,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of a Four (4) Storey w/ Deck Academic Building (Phase 1) -ITB 2018-15**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. **The Davao del Norte State College** now invites bids for the **Construction of a Four (4) Storey w/ Deck Academic Building (Phase 1)**. The Completion of the Works is required for **Three Hundred (300) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **Davao del Norte State College**, and inspect the Bidding Documents at the address given below from Monday to Friday, 8:00 AM-5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested bidders **on or before January 10, 2019** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty Five Thousand Pesos only (Php 25,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.


6. The **Davao del Norte State College** will hold a Pre-Bid Conference on **January 3, 2019, 2:00 PM** at DNSC Administration Building Conference Room which shall be open to all prospective bidders.

7. Bids must be delivered to the address below on or before **January 21, 2019, 2:00 PM**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Instructions to Bidders Clause 18.

Bid opening shall be on **January 21, 2019, 2:00 PM** at DNSC Administration Building Conference Room, New Visayas, Panabo City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Other schedule of BAC activities is provided below and the Davao del Norte State College reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
